Why join the Polystyrene Association of SA?

The Department of Environment, Forestry and Fisheries (DEFF) has promulgated the National Environmental Management Waste Act (NEMWA), which requires a proactive approach to managing materials (packaging included) so that the waste stream is minimized and producer responsibility is demonstrated.

In view of this pending legislation which aims to make the packaging industry responsible for the recycling of their products through Extended Producer Responsibility, it has become essential for manufacturers and other role-players to be part of an industry body and subscribe to the Industry Waste Management Plan (PPIWMP). The Polystyrene Association of SA is a single voice of the industry with a budget approved to represent the industry and thereby enhances the status and influence of our members.

Membership cost:

The cost of membership for convertors of polystyrene packaging is R92 per kg, which is less than 0.05% of raw material cost. This contribution enables the industry to reach its collection and recycling goals.

Achievements to date include:

- A 17 % increase in recycling of packaging polystyrene this past year;
- Establishing specific recycling projects for polystyrene and thereby ensuring recycling targets are met.

Without our industry's membership and support we will not reach the recycling targets set. Our success relies on reaching a critical mass with 100% representation of industry.
